- Install and modify aircraft engines or other aircraft systems such as mechanical and hydraulic systems, flight control, fuel systems and pneumatic systems;
- Dismantle airframes, engines or other aircraft systems for repair, return to a good condition, clean and reassemble them;
- Perform routine maintenance and report/write up defects and order parts;
- Check aircraft structural and mechanical systems and ensure that these systems meet the performance and safety standards of Transport Canada and AAR MRO Services Windsor;
- Monitor quality of operations, identify anomalies and make necessary corrections;
- Perform surveys of parameters;
- Read and interpret the parameters
- Actively participate in AAR Aircraft Services Windsor's Safety Management System (SMS), including reporting safety hazards and incidents encountered in daily operations; understand and promote the company safety policy;
- Keep detailed reports on the repair, inspection and certification of aircraft;
